2025-2026 Budget

Darryl Yorkman, Controller, will present the budget for board review and approval.

234 Essex Street— The property at 234 Essex Street, which was severely damaged by fire and has since been demolished, is no longer viable for residential use. In response, the City is facilitating the transfer of 34 North King Street to the Gloucester City Housing Authority (GCHA) as a replacement site. This acquisition ensures GCHA can continue to meet the community's housing needs and supports the City's broader revitalization efforts.

Insurance Claim—335 Hudson Street resident Stacy Johnson has filed a civil action complaint against the Gloucester City Housing Authority. The complaint has been sent to both Brown & Brown and Connerstrong, and legal counsel from Brown & Brown has been contacted.

This property is 96.70% occupied in available units. 234 Street has been marked as an uninhabitable unit and taken offline (no subsidy will be received).
